- A BILL FOR AN ACT relating to the Securities Act of Nebraska; to amend
 section 8-1111, Revised Statutes Cumulative Supplement, 2014; to
 authorize crowdfunding as prescribed and to exempt crowdfunding from
 registration; and to repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

Section 1. Section 8-1111, Revised Statutes Cumulative Supplement,
 2014, is amended to read:

8-1111 Except as provided in this section, sections 8-1103 to 8-1109
shall not apply to any of the following transactions:

5 (1) Any isolated transaction, whether effected through a broker-6 dealer or not;

7 (2)(a) Any nonissuer transaction by a registered agent of a 8 registered broker-dealer, and any resale transaction by a sponsor of a 9 unit investment trust registered under the Investment Company Act of 10 1940, in a security of a class that has been outstanding in the hands of 11 the public for at least ninety days if, at the time of the transaction:

(i) The issuer of the security is actually engaged in business and
not in the organization stage or in bankruptcy or receivership and is not
a blank check, blind pool, or shell company whose primary plan of
business is to engage in a merger or combination of the business with, or
an acquisition of, an unidentified person or persons;

17 (ii) The security is sold at a price reasonably related to the18 current market price of the security;

(iii) The security does not constitute the whole or part of an
unsold allotment to, or a subscription or participation by, the brokerdealer as an underwriter of the security;

(iv) A nationally recognized securities manual designated by rule
and regulation or order of the director or a document filed with the
Securities and Exchange Commission which is publicly available through
the Electronic Data Gathering, Analysis, and Retrieval System (EDGAR)
contains:

27 (A) A description of the business and operations of the issuer;

(B) The names of the issuer's officers and the names of the issuer's
directors, if any, or, in the case of a non-United-States issuer, the
corporate equivalents of such persons in the issuer's country of
domicile;

1 (C) An audited balance sheet of the issuer as of a date within 2 eighteen months or, in the case of a reorganization or merger when 3 parties to the reorganization or merger had such audited balance sheet, a 4 pro forma balance sheet; and

5 (D) An audited income statement for each of the issuer's immediately 6 preceding two fiscal years, or for the period of existence of the issuer 7 if in existence for less than two years, or, in the case of a 8 reorganization or merger when the parties to the reorganization or merger 9 had such audited income statement, a pro forma income statement; and

10 (v) The issuer of the security has a class of equity securities 11 listed on a national securities exchange registered under the Securities 12 Exchange Act of 1934 or designated for trading on the National 13 Association of Securities Dealers Automated Quotation System (NASDAQ), 14 unless:

(A) The issuer of the security is a unit investment trust registeredunder the Investment Company Act of 1940;

17 (B) The issuer of the security has been engaged in continuous18 business, including predecessors, for at least three years; or

19 (C) The issuer of the security has total assets of at least two 20 million dollars based on an audited balance sheet as of a date within 21 eighteen months or, in the case of a reorganization or merger when 22 parties to the reorganization or merger had such audited balance sheet, a 23 pro forma balance sheet; or

(b) Any nonissuer transaction in a security by a registered agent ofa registered broker-dealer if:

(i) The issuer of the security is actually engaged in business and
not in the organization stage or in bankruptcy or receivership and is not
a blank check, blind pool, or shell company whose primary plan of
business is to engage in a merger or combination of the business with, or
an acquisition of, an unidentified person or persons; and

31 (ii) The security is senior in rank to the common stock of the

issuer both as to payment of dividends or interest and upon dissolution or liquidation of the issuer and such security has been outstanding at least three years and the issuer or any predecessor has not defaulted within the current fiscal year or the three immediately preceding fiscal years in the payment of any dividend, interest, principal, or sinking fund installment on the security when due and payable;

7 (3) Any nonissuer transaction effected by or through a registered 8 agent of a registered broker-dealer pursuant to an unsolicited order or 9 offer to buy, but the director may by rule or regulation require that the 10 customer acknowledge upon a specified form that the sale was unsolicited 11 and that a signed copy of each such form be preserved by the broker-12 dealer for a specified period;

(4) Any transaction between the issuer or other person on whose
behalf the offering is made and an underwriter or among underwriters;

(5) Any transaction in a bond or other evidence of indebtedness 15 16 secured by a real or chattel mortgage or deed of trust or by an agreement for the sale of real estate or chattels if the entire mortgage, deed of 17 trust, or agreement, together with all the bonds or other evidences of 18 indebtedness secured thereby, are offered and sold as a unit. Such 19 exemption shall not apply to any transaction in a bond or other evidence 20 of indebtedness secured by a real estate mortgage or deed of trust or by 21 an agreement for the sale of real estate if the real estate securing the 22 23 evidences of indebtedness are parcels of real estate the sale of which 24 requires the subdivision in which the parcels are located to be 25 registered under the Interstate Land Sales Full Disclosure Act, 15 U.S.C. 1701 et seq., as the act existed on January 1, 2015 2013; 26

27 (6) Any transaction by an executor, personal representative,
28 administrator, sheriff, marshal, receiver, guardian, or conservator;

(7) Any transaction executed by a bona fide pledgee without any
purpose of evading the Securities Act of Nebraska;

31 (8) Any offer or sale to a bank, savings institution, trust company,

insurance company, investment company as defined in the Investment 1 2 Company Act of 1940, pension or profit-sharing trust, or other financial institution or institutional buyer, to an individual accredited investor, 3 4 or to a broker-dealer, whether the purchaser is acting for itself or in some fiduciary capacity. For purposes of this subdivision, the term 5 6 "individual accredited investor" means (a) any director, executive 7 officer, or general partner of the issuer of the securities being offered or sold, or any director, executive officer, or general partner of a 8 9 general partner of that issuer, (b) any manager of a limited liability company that is the issuer of the securities being offered or sold, (c) 10 any natural person whose individual net worth, or joint net worth with 11 that person's spouse, at the time of his or her purchase, exceeds one 12 13 million dollars, excluding the value of the primary residence of such 14 person, or (d) any natural person who had an individual income in excess of two hundred thousand dollars in each of the two most recent years or 15 joint income with that person's spouse in excess of three hundred 16 17 thousand dollars in each of those years and has a reasonable expectation of reaching the same income level in the current year; 18

(9)(a) Any transaction pursuant to an offering in which sales are 19 made to not more than fifteen persons, other than those designated in 20 subdivisions (8), (11), and (17) of this section, in this state during 21 any period of twelve consecutive months if (i) the seller reasonably 22 23 believes that all the buyers are purchasing for investment, (ii) no 24 commission or other remuneration is paid or given directly or indirectly 25 for soliciting any prospective buyer except to a registered agent of a registered broker-dealer, (iii) a notice generally describing the terms 26 of the transaction and containing a representation that the conditions of 27 28 this exemption are met is filed by the seller with the director within thirty days after the first sale for which this exemption is claimed, 29 except that failure to give such notice may be cured by an order issued 30 by the director in his or her discretion, and (iv) no general or public 31

1 advertisements or solicitations are made.

2 (b) If a seller (i) makes sales pursuant to this subdivision for five consecutive twelve-month periods or (ii) makes sales of at least one 3 4 million dollars from an offering or offerings pursuant to this subdivision, the seller shall, within ninety days after the earlier of 5 either such occurrence, file with the director audited financial 6 7 statements and a sales report which lists the names and addresses of all purchasers and holders of the seller's securities and the amount of 8 9 securities held by such persons. Subsequent thereto, such seller shall file audited financial statements and sales reports with the director 10 each time an additional one million dollars in securities is sold 11 pursuant to this subdivision or after the elapse of each additional 12 sixty-month period during which sales are made pursuant to this 13 subdivision; 14

(10) Any offer or sale of a preorganization certificate or subscription if (a) no commission or other remuneration is paid or given directly or indirectly for soliciting any prospective subscriber, (b) the number of subscribers does not exceed ten, and (c) no payment is made by any subscriber;

(11) Any transaction pursuant to an offer to existing security 20 holders of the issuer, including persons who at the time of the 21 transaction are holders of convertible securities, nontransferable 22 warrants, or transferable warrants exercisable within not more than 23 24 ninety days of their issuance, if (a) no commission or other 25 remuneration, other than a standby commission, is paid or given directly or indirectly for soliciting any security holder in this state or (b) the 26 issuer first files a notice specifying the terms of the offer and the 27 28 director does not by order disallow the exemption within the next five full business days; 29

30 (12) Any offer, but not a sale, of a security for which registration
 31 statements have been filed under both the Securities Act of Nebraska and

the Securities Act of 1933 if no stop order or refusal order is in effect and no public proceeding or examination looking toward such an order is pending under either the Securities Act of Nebraska or the Securities Act of 1933;

5 (13) The issuance of any stock dividend, whether the corporation 6 distributing the dividend is the issuer of the stock or not, if nothing 7 of value is given by the stockholders for the distribution other than the 8 surrender of a right to a cash dividend when the stockholder can elect to 9 take a dividend in cash or stock;

(14) Any transaction incident to a right of conversion or a
statutory or judicially approved reclassification, recapitalization,
reorganization, quasi-reorganization, stock split, reverse stock split,
merger, consolidation, or sale of assets;

(15) Any transaction involving the issuance for cash of any evidence 14 of ownership interest or indebtedness by an agricultural cooperative 15 formed as a corporation under section 21-1301 or 21-1401 if the issuer 16 has first filed a notice of intention to issue with the director and the 17 director has not by order, mailed to the issuer by certified or 18 19 registered mail within ten business days after receipt thereof, disallowed the exemption; 20

(16) Any transaction in this state not involving a public offering 21 when (a) there is no general or public advertising or solicitation, (b) 22 no commission or remuneration is paid directly or indirectly for 23 soliciting any prospective buyer, except to a registered agent of a 24 25 registered broker-dealer or registered issuer-dealer, (c) a notice generally describing the terms of the transaction and containing a 26 representation that the conditions of this exemption are met is filed by 27 28 the seller with the director within thirty days after the first sale for which this exemption is claimed, except that failure to give such notice 29 may be cured by an order issued by the director in his or her discretion, 30 (d) a filing fee of two hundred dollars is paid at the time of filing the 31

notice, and (e) any such transaction is effected in accordance with rules 1 2 and regulations adopted and promulgated by the director relating to this section when the director finds in adopting and promulgating such rules 3 4 and regulations that the applicability of sections 8-1104 to 8-1107 is 5 not necessary or appropriate in the public interest or for the protection of investors. For purposes of this subdivision, not involving a public 6 offering means any offering in which the seller has reason to believe 7 that the securities purchased are taken for investment and in which each 8 9 offeree, by reason of his or her knowledge about the affairs of the issuer or otherwise, does not require the protections afforded by 10 11 registration under sections 8-1104 to 8-1107 in order to make a reasonably informed judgment with respect to such investment; 12

(17) The issuance of any investment contract issued in connection with an employee's stock purchase, savings, pension, profit-sharing, or similar benefit plan if no commission or other remuneration is paid or given directly or indirectly for soliciting any prospective buyer except to a registered agent of a registered broker-dealer;

(18) Any interest in a common trust fund or similar fund maintained 18 19 by a bank or trust company organized and supervised under the laws of any state or a bank organized under the laws of the United States for the 20 collective investment and reinvestment of funds contributed to such 21 common trust fund or similar fund by the bank or trust company in its 22 capacity as trustee, personal representative, administrator, or guardian 23 24 and any interest in a collective investment fund or similar fund 25 maintained by the bank or trust company for the collective investment of funds contributed to such collective investment fund or similar fund by 26 the bank or trust company in its capacity as trustee or agent which 27 28 interest is issued in connection with an employee's savings, pension, profit-sharing, or similar benefit plan or a self-employed person's 29 retirement plan, if a notice generally describing the terms of the 30 collective investment fund or similar fund is filed by the bank or trust 31

company with the director within thirty days after the establishment of
 the fund. Failure to give the notice may be cured by an order issued by
 the director in his or her discretion;

4 (19) Any transaction in which a United States Series EE Savings Bond 5 is given or delivered with or as a bonus on account of any purchase of 6 any item or thing;

7 (20) Any transaction in this state not involving a public offering by a Nebraska issuer selling solely to Nebraska residents, when (a) any 8 9 such transaction is effected in accordance with rules and regulations adopted and promulgated by the director relating to this section when the 10 director finds in adopting and promulgating such rules and regulations 11 that the applicability of sections 8-1104 to 8-1107 is not necessary or 12 13 appropriate in the public interest or for the protection of investors, (b) no commission or remuneration is paid directly or indirectly for 14 soliciting any prospective buyer, except to a registered agent of a 15 16 registered broker-dealer or registered issuer-dealer, (c) a notice 17 generally describing the terms of the transaction and containing a representation that the conditions of this exemption are met is filed by 18 19 the seller with the director no later than twenty days prior to any sales for which this exemption is claimed, except that failure to give such 20 notice may be cured by an order issued by the director in his or her 21 22 discretion, (d) a filing fee of two hundred dollars is paid at the time of filing the notice, and (e) there is no general or public advertising 23 24 or solicitation;

(21) Any transaction by a person who is an organization described in section 501(c)(3) of the Internal Revenue Code as defined in section 49-801.01 involving an offering of interests in a fund described in section 3(c)(10)(B) of the Investment Company Act of 1940 solely to persons who are organizations described in section 501(c)(3) of the Internal Revenue Code as defined in section 49-801.01 when (a) there is no general or public advertising or solicitation, (b) a notice generally

1 describing the terms of the transaction and containing a representation 2 that the conditions of this exemption are met is filed by the seller with the director within thirty days after the first sale for which this 3 4 exemption is claimed, except that failure to give such notice may be cured by an order issued by the director in his or her discretion, and 5 (c) any such transaction is effected by a trustee, director, officer, 6 employee, or volunteer of the seller who is either a volunteer or is 7 the overall fundraising activities of a charitable 8 engaged in 9 organization and receives no commission or other special compensation based on the number or the value of interests sold in the fund; 10

11 (22) Any offer or sale of any viatical settlement contract or any 12 fractionalized or pooled interest therein in a transaction that meets all 13 of the following criteria:

14 (a) Sales of such securities are made only to the following15 purchasers:

16 (i) A natural person who, either individually or jointly with the 17 person's spouse, (A) has a minimum net worth of two hundred fifty thousand dollars and had taxable income in excess of one hundred twenty-18 five thousand dollars in each of the two most recent years and has a 19 reasonable expectation of reaching the same income level in the current 20 year or (B) has a minimum net worth of five hundred thousand dollars. Net 21 worth shall be determined exclusive of home, home furnishings, and 22 23 automobiles;

(ii) A corporation, partnership, or other organization specifically
formed for the purpose of acquiring securities offered by the issuer in
reliance upon this exemption if each equity owner of the corporation,
partnership, or other organization is a person described in subdivision
(22)(a)(i) of this section;

(iii) A pension or profit-sharing trust of the issuer, a selfemployed individual retirement plan, or an individual retirement account,
if the investment decisions made on behalf of the trust, plan, or account

1 are made solely by persons described in subdivision (22)(a)(i) of this 2 section; or

3 (iv) An organization described in section 501(c)(3) of the Internal 4 Revenue Code as defined in section 49-801.01, or a corporation, 5 Massachusetts or similar business trust, or partnership with total assets 6 in excess of five million dollars according to its most recent audited 7 financial statements;

8 (b) The amount of the investment of any purchaser, except a 9 purchaser described in subdivision (a)(ii) of this subdivision, does not 10 exceed five percent of the net worth, as determined by this subdivision, 11 of that purchaser;

(c) Each purchaser represents that the purchaser is purchasing for the purchaser's own account or trust account, if the purchaser is a trustee, and not with a view to or for sale in connection with a distribution of the security;

16 (d)(i) Each purchaser receives, on or before the date the purchaser 17 remits consideration pursuant to the purchase agreement, the following 18 information in writing:

19 (A) The name, principal business and mailing addresses, and20 telephone number of the issuer;

(B) The suitability standards for prospective purchasers as set
forth in subdivision (a) of this subdivision;

(C) A description of the issuer's type of business organization and
the state in which the issuer is organized or incorporated;

(D) A brief description of the business of the issuer;

(E) If the issuer retains ownership or becomes the beneficiary of the insurance policy, an audit report from an independent certified public accountant together with a balance sheet and related statements of income, retained earnings, and cash flows that reflect the issuer's financial position, the results of the issuer's operations, and the issuer's cash flows as of a date within fifteen months before the date of

the initial issuance of the securities described in this subdivision. The financial statements shall be prepared in conformity with generally accepted accounting principles. If the date of the audit report is more than one hundred twenty days before the date of the initial issuance of the securities described in this subdivision, the issuer shall provide unaudited interim financial statements;

7 (F) The names of all directors, officers, partners, members, or8 trustees of the issuer;

(G) A description of any order, judgment, or decree that is final as 9 to the issuing entity of any state, federal, or foreign governmental 10 agency or administrator, or of any state, federal, or foreign court of 11 competent jurisdiction (I) revoking, suspending, denying, or censuring 12 for cause any license, permit, or other authority of the issuer or of any 13 director, officer, partner, member, trustee, or person owning 14 or 15 controlling, directly or indirectly, ten percent or more of the outstanding interest or equity securities of the issuer, to engage in the 16 securities, commodities, franchise, insurance, real estate, or lending 17 business or in the offer or sale of securities, commodities, franchises, 18 19 insurance, real estate, or loans, (II) permanently restraining, suspending, or censuring any such person from 20 enjoining, barring, engaging in or continuing any conduct, practice, or employment in 21 22 connection with the offer or sale of securities, commodities, franchises, insurance, real estate, or loans, (III) convicting any such person of, or 23 24 pleading nolo contendere by any such person to, any felony or misdemeanor involving a security, commodity, franchise, insurance, real estate, or 25 loan, or any aspect of the securities, commodities, franchise, insurance, 26 real estate, or lending business, or involving dishonesty, fraud, deceit, 27 28 embezzlement, fraudulent conversion, or misappropriation of property, or (IV) holding any such person liable in a civil action involving breach of 29 a fiduciary duty, fraud, deceit, embezzlement, fraudulent conversion, or 30 misappropriation of property. This subdivision does not apply to any 31

order, judgment, or decree that has been vacated or overturned or is more
 than ten years old;

3 (H) Notice of the purchaser's right to rescind or cancel the
4 investment and receive a refund;

5 (I) A statement to the effect that any projected rate of return to the purchaser from the purchase of a viatical settlement contract or any 6 7 fractionalized or pooled interest therein is based on an estimated life expectancy for the person insured under the life insurance policy; that 8 9 the return on the purchase may vary substantially from the expected rate of return based upon the actual life expectancy of the insured that may 10 be less than, may be equal to, or may greatly exceed the estimated life 11 expectancy; and that the rate of return would be higher if the actual 12 life expectancy were less than, and lower if the actual life expectancy 13 were greater than, the estimated life expectancy of the insured at the 14 time the viatical settlement contract was closed; 15

16 (J) A statement that the purchaser should consult with his or her 17 tax advisor regarding the tax consequences of the purchase of the 18 viatical settlement contract or any fractionalized or pooled interest 19 therein; and

20 (K) Any other information as may be prescribed by rule <u>and</u>
 21 <u>regulation of the director; and</u>

(ii) The purchaser receives in writing at least five business daysprior to closing the transaction:

(A) The name, address, and telephone number of the issuing insurance
company and the name, address, and telephone number of the state or
foreign country regulator of the insurance company;

(B) The total face value of the insurance policy and the percentageof the insurance policy the purchaser will own;

(C) The insurance policy number, issue date, and type;

30 (D) If a group insurance policy, the name, address, and telephone
 31 number of the group and, if applicable, the material terms and conditions

1 of converting the policy to an individual policy, including the amount of 2 increased premiums;

3 (E) If a term insurance policy, the term and the name, address, and 4 telephone number of the person who will be responsible for renewing the 5 policy if necessary;

6 (F) That the insurance policy is beyond the state statute for 7 contestability and the reason therefor;

(G) The insurance policy premiums and terms of premium payments;

9 (H) The amount of the purchaser's money that will be set aside to 10 pay premiums;

(I) The name, address, and telephone number of the person who will be the insurance policyowner and the person who will be responsible for paying premiums;

(J) The date on which the purchaser will be required to pay premiumsand the amount of the premium, if known; and

16 (K) Any other information as may be prescribed by rule <u>and</u> 17 <u>regulation</u> of the director;

(e) The purchaser may rescind or cancel the purchase for any reason 18 by giving written notice of rescission or cancellation to the issuer or 19 the issuer's agent within (i) fifteen calendar days after the date the 20 purchaser remits the required consideration or receives the disclosure 21 required under subdivision (d)(i) of this subdivision and (ii) five 22 business days after the date the purchaser receives the disclosure 23 24 required by subdivision (d)(ii) of this subdivision. No specific form is required for the rescission or cancellation. The notice is effective when 25 personally delivered, deposited in the United States mail, or deposited 26 27 with a commercial courier or delivery service. The issuer shall refund 28 all the purchaser's money within seven calendar days after receiving the notice of rescission or cancellation; 29

30 (f) A notice of the issuer's intent to sell securities pursuant to31 this subdivision, signed by a duly authorized officer of the issuer and

notarized, together with a filing fee of two hundred dollars, is filed
 with the Department of Banking and Finance before any offers or sales of
 securities are made under this subdivision. Such notice shall include:

4 (i) The issuer's name, the issuer's type of organization, the state 5 in which the issuer is organized, the date the issuer intends to begin 6 selling securities within or from this state, and the issuer's principal 7 business;

8

(ii) A consent to service of process; and

9 (iii) An audit report of an independent certified public accountant together with a balance sheet and related statements of income, retained 10 earnings and cash flows that reflect the issuer's financial position, the 11 results of the issuer's operations, and the issuer's cash flows as of a 12 13 date within fifteen months before the date of the notice prescribed in 14 subdivision. The financial statements shall be prepared this in conformity with generally accepted accounting principles and shall be 15 16 examined according to generally accepted auditing standards. If the date 17 of the audit report is more than one hundred twenty days before the date of the notice prescribed in this subdivision, the issuer shall provide 18 unaudited interim financial statements; 19

(g) No commission or remuneration is paid directly or indirectly for
 soliciting any prospective purchaser, except to a registered agent of a
 registered broker-dealer or registered issuer-dealer; and

(h) At least ten days before use within this state, the issuer files with the department all advertising and sales materials that will be published, exhibited, broadcast, or otherwise used, directly or indirectly, in the offer or sale of a viatical settlement contract in this state;—or

(23) Any transaction in this state not involving a public offering
by a Nebraska issuer selling solely to Nebraska residents when:

30 (a) The proceeds from all sales of securities by the issuer in any
 31 two-year period do not exceed two hundred fifty thousand dollars and at

1 least eighty percent of the proceeds are used in Nebraska;

(b) No commission or other remuneration is paid or given directly or
indirectly for soliciting any prospective buyer except to a registered
agent of a registered broker-dealer;

5 (c) The issuer, any partner or limited liability company member of 6 the issuer, any officer, director, or any person occupying a similar 7 status of the issuer, any person performing similar functions for the 8 issuer, or any person holding a direct or indirect ownership interest in 9 the issuer or in any way a beneficial interest in such sale of securities 10 of the issuer, has not been:

(i) Found by a final order of any state or federal administrative
agency or a court of competent jurisdiction to have violated any
provision of the Securities Act of Nebraska or a similar act of any other
state or of the United States;

(ii) Convicted of any felony or misdemeanor in connection with the
offer, purchase, or sale of any security or any felony involving fraud or
deceit, including, but not limited to, forgery, embezzlement, obtaining
money under false pretenses, larceny, or conspiracy to defraud;

(iii) Found by any state or federal administrative agency or court
of competent jurisdiction to have engaged in fraud or deceit, including,
but not limited to, making an untrue statement of a material fact or
omitting to state a material fact; or

(iv) Temporarily or preliminarily restrained or enjoined by a court of competent jurisdiction from engaging in or continuing any conduct or practice in connection with the purchase or sale of any security or involving the making of any false filing with any state or with the Securities and Exchange Commission;

(d)(i) At least fifteen business days prior to the offer or sale,
the issuer files a notice with the director, which notice shall include:

30 (A) The name, address, telephone number, and email address of the31 issuer;

(B) The name and address of each person holding direct or indirect
 ownership or beneficial interest in the issuer;

3 (C) The amount of the offering; and

The director may by order deny or revoke the exemption specified in 2 3 subdivision (2) of this section with respect to a specific security. Upon the entry of such an order, the director shall promptly notify all 4 registered broker-dealers that it has been entered and of the reasons 5 therefor and that within fifteen business days of the receipt of a 6 written request the matter will be set down for hearing. If no hearing is 7 requested within fifteen business days of the issuance of the order and 8 9 none is ordered by the director, the order shall automatically become a final order and shall remain in effect until it is modified or vacated by 10 the director. If a hearing is requested or ordered, the director, after 11 notice of and opportunity for hearing to all interested persons, shall 12 enter his or her written findings of fact and conclusions of law and may 13 may operate 14 modify, or vacate the order.
